CONSIDER AND APPROVE AN ORDINANCE AUTHORIZING THE ISSUANCE, SALE AND DELIVERY OF TOWN OF RANCHO VIEJO, TEXAS GENERAL 2012; LEVYING OBLIGATION REFUNDING BONDS, SERIES CONTINUING DIRECT ANNUAL AD VALOREM TAX; AUTHORIZING THE FUNDING OF CERTAIN OUTSTANDING OBLIGATIONS; AUTHORIZING THE EXECUTION OF A BOND PURCHASE AGREEMENT; AND MAKING OTHER REGARDING SUCH BONDS AND MATTERS INCIDENT PROVISIONS THERETO:

Motion was made by Alderwoman Hager, seconded by Alderwoman Rathbun, and unanimously carried, to approve Ordinance No. 202 - AN ORDINANCE AUTHORIZING THE ISSUANCE, SALE AND DELIVERY OF TOWN OF RANCHO VIEJO, TEXAS GENERAL OBLIGATION REFUNDING BONDS, SERIES 2012; LEVYING A CONTINUING DIRECT ANNUAL AD VALOREM TAX; AUTHORIZING THE FUNDING OF CERTAIN OUTSTANDING OBLIGATIONS; AUTHORIZING THE EXECUTION OF A BOND PURCHASE AGREEMENT; AND MAKING OTHER PROVISIONS REGARDING SUCH BONDS AND MATTERS INCIDENT THERETO. The bond maturity schedule is 15 years.

CONSIDERATION/ADOPTION OF BUDGET ORDINANCE FOR FISCAL YEAR OCTOBER 1, 2012 TO SEPTEMBER 30, 2013:

Motion was made by Alderwoman Rathbun, to approve the current budget with the following amendments: Code 2150.0000 Payroll-Administration to be \$114,125; Code 3300.0000 Public Relations to be \$1,900; Code 4140.0000 Clothing-Police to be \$5,933; Code 4150.0000 Payroll-Police to be \$323,720; Code 4200.0000 Cleaning of Uniforms to be \$3,672; Code 4310.0000 Police Contract Labor to be \$40,000; Code 4331.0000 Police

Investigation \$7,740; Code 25131.0500 Automobile Equipment to be \$500; Code 4291.0000 Fire Prevention/1st Aid to be \$1,607; Code 4291.6220 Hurricane Preparedness to be \$1,800; Code 6100.0000 Street Rehabilitation Reserve to be \$33,366; Code 6400.0000 Lighting Installation to be \$1,600; and with these changes adjust Code 2160.0000 Retirement-Administration to be \$11,363; 3160.0000 S.S./Medicare to be \$7,335; Code 2161.0000 Liability to be \$21,700; Code 4160.0000 Insurance Tax to be \$31,621; and Code Retirement & Empl. 4161.0000 Medicare & S.S. to be \$14,546. Motion was seconded by Alderwoman Guerrero, and unanimously approved, to make the changes.

After further discussion motion was made by Alderwoman Guerrero, seconded by Alderwoman Hager, to amend code 6100.0000 Street Rehabilitation Reserve to be \$34,366. Motion passed with the following vote:

ABSTAINING: None

Motion was made by Alderwoman Rathbun, seconded by Alderwoman Guerrero, and unanimously carried, to adjust Code 4150.0000 Payroll-Police to be \$324,720.

Motion was made by Alderwoman Rathbun, seconded by Alderwoman Hager, and unanimously carried, to adjust Code 2150.0000 Payroll-Administration to be \$114,625.

Motion was made by Alderwoman Hager, seconded by Alderwoman Guerrero, and unanimously carried, to recess at 7:02 P.M.

Motion was made by Alderwoman Guerrero, seconded by Alderwoman Rathbun, and unanimously carried, to resume the meeting at 7:25 P.M. A revised budget was distributed to the board showing the amendments as listed above along with line items adjusted reflecting the final payroll adjustments.

Mayor Medrano asked Mr. Rentfro to restate the motion and he clarified that the motion was made by Alderwoman Rathbun, and seconded by Alderwoman Guerrero, to adopt the Budget for Fiscal Year 2012-2013 showing total expenses of \$1,151,051.02 and assuming the same tax rate as this year of .391934 with 97% collections which would reflect total revenues of \$1,157,362.00; and to include the statement that this budget will raise more

total property taxes than last year's budget by \$18,473 or 2.182576%, and of that amount \$14,362 is tax revenue to be raised from new property added to the roll this year; and to adopt ORDINANCE NO. 203 - AN ORDINANCE OF THE BOARD OF ALDERMEN APPROVING AND ADOPTING THE BUDGET FOR THE TOWN OF RANCHO VIEJO, TEXAS, AS PREPARED BY THE MAYOR FOR THE FISCAL YEAR 2012-2013 with the amendments reflected above. This motion was carried unanimously.

CONSIDERATION/RATIFICATION OF THE PROPERTY TAX (REVENUE) INCREASE REFLECTED IN THE BUDGET FOR FISCAL YEAR OCTOBER 1, 2012 TO SEPTEMBER 30, 2013:

Motion was made by Alderwoman Hager, seconded by Alderwoman Guerrero, and unanimously carried, to ratify that this budget will raise more total property taxes than last year's budget by \$18,473 or 2.182576%, and of that amount \$14,362 is tax revenue to be raised from new property added to the roll this year.

CONSIDERATION/ADOPTION OF ORDINANCE TO ESTABLISH AD VALOREM TAX RATE TO PROVIDE FOR BUDGET EXPENSES FOR FISCAL YEAR 2012-2013:

Motion was made by Alderwoman Hager, seconded by Alderwoman Guerrero, and unanimously carried, to pass, adopt and approve ORDINANCE NO. 204 - AN ORDINANCE ESTABLISHING THE AD VALOREM AND PERSONAL PROPERTY TAX RATE FOR THE TAX YEAR 2012, SETTING THE ASSESSED VALUATION AT ONE HUNDRED (100%) PERCENT OF THE FAIR MARKET VALUE, PROVIDING FOR A HOMESTEAD EXEMPTION OF \$5,000, PROVIDING FOR DISCOUNTS IN THE EVENT OF EARLY PAYMENT, AND PROVIDING FOR PENALTY AND INTEREST IN ACCORDANCE WITH STATE LAW AND PROVIDING FOR SEVERABILITY. The total tax rate adopted was \$.391934.

Motion was made by Alderwoman Rathbun, seconded by Alderwoman Guerrero, and unanimously carried, to approve the Budget Amendment for 2011/2012.
