John Shergold talked about the proper regulations for development that include wastewater, electricity, streets, and emergency services. He stated that studies should be conducted to be able to provide the resources needed for the proposed development.

An Nix stated that with regard to the posted agenda item #7, she is opposed to the reduction of lot size because it would not benefit the Town. She also said that she objected to a private session for item #19A with regard to town planning, land use, or zoning.

Roberto Medrano asked when comments would be reviewed for agenda items, now or under the actual agenda item. Mayor Guerrero responded and said any comments on agenda items were to be at this time.

Fred Kennedy commented on the property maintenance in Rancho Viejo and asked about beautification.

Tionte' Boggan talked about a company for recycling.

Peter Harris asked about the deed restrictions for the resort or for zoning. He also stated that there is currently undeveloped property already in Rancho Viejo off the continuation of Villa Drive. He also stated that he is against item #7 and the lot reduction for a section that is not even a part of the town yet, it would have to be annexed first.

There are many different perspectives, and it is time that we think about the vision of what we want for our beautiful Town. There is currently no Comprehensive Plan in place for the Town, the Strategic Planning Committee was developed to uphold a plan that is not active.

The Mayor and Board have been talking about the Town and its residents' input for the community to mold ordinances in the interests of the Town. The proposal is for the Town to request Qualifications for Comprehensive Planning services and to get a company or a firm to help the Town to start developing the proper plan for the future of Rancho Viejo.

The Aldermen agreed and said that it was much needed for Rancho Viejo. Motion was made by Alderman Hernandez, seconded by Alderman Ricoy, and unanimously carried, to approve the issuance of a Request of Qualifications for Comprehensive Planning Services to the Town of Rancho Viejo.

ORDINANCE NO.

AN ORDINANCE ESTABLISHING THE AD VALOREM AND PERSONAL PROPERTY TAX RATE FOR THE TAX YEAR 2022, SETTING THE ASSESSED VALUATION AT ONE HUNDRED (100%) PERCENT OF THE FAIR MARKET VALUE, PROVIDING FOR A HOMESTEAD EXEMPTION OF \$5,000, PROVIDING FOR DISCOUNTS IN THE EVENT OF EARLY PAYMENT, AND PROVIDING FOR PENALTY AND INTEREST IN ACCORDANCE WITH STATE LAW AND PROVIDING FOR SEVERABILITY

NOW THEREFORE, BE IT ORDAINED BY THE BOARD OF ALDERMEN OF THE TOWN OF RANCHO VIEJO, TEXAS:

Section 1. There is hereby established a tax rate for the tax year 2021:

- \$.361330 Maintenance & Operation Tax Rate
- \$.088670 Debt Tax Rate
- \$.450000 Total Tax Rate

for each \$100.00 of assessed valuation of all ad valorem and personal property taxable under the laws of this State by the Town of Rancho Viejo.

THIS TAX RATE WILL RAISE LESS REVENUE FOR MAINTENANCE AND OPERATIONS THAN LAST YEAR'S TAX RATE. THE TAX RATE WILL EFFECTIVELY BE LESS BY 0.549095 PERCENT AND WILL RAISE LESS REVENUE FOR MAINTENANCE AND OPERATIONS ON A \$100,000 HOME BY APPROXIMATELY \$2.00.

Section 2. There is hereby established an assessed valuation of one hundred (100%) percent of the fair market value of all real and personal property according to the certified tax rolls of the Town of Rancho Viejo.

Section 3. There is hereby granted a homestead exemption to qualified homeowners at the level of \$5,000 on the ad valorem tax for the tax year 2022.

Section 4. There is hereby granted a discount for early payment of the 2022 taxes which discount shall be equal to and the same as that granted by CAMERON COUNTY, the agency under contract to collect the taxes of this Town, said discount all being pursuant to State law.

Section 5. Any payment not timely made shall bear such penalty and interest as is provided by State law.

Section 6. If any section, paragraph, subdivision, clause, phrase, or provision of the Ordinance shall be adjudged invalid or held unconstitutional, the same shall not affect the validity of this Ordinance as whole or any part or provision thereof, other than the part so decided to be invalid or unconstitutional.

Section 7. This ordinance shall become effective upon passage.
