2. ROLL CALL:

John Clint, Halff Associates went over some of the details of the annexation request. Alderman Vera asked about the water and sewer agreement. Mr. Clint mentioned that before the final plat is approved, they will have an agreement to be annexed into the Valley Municipal Utility District for water and sewer services.

Motion was made by Alderman Johnson, seconded by Alderman Ricoy, and unanimously carried to approve Ordinance No. 259 – AN ORDINANCE ANNEXING THE HEREINAFTER DESCRIBED TERRITORY TO THE TOWN OF RANCHO VIEJO, CAMERON COUNTY, TEXAS, AND EXTENDING THE BOUNDARY LIMITS OF SAID TOWN SO AS TO INCLUDE SAID HEREINAFTER DESCRIBED PROPERTY WITHIN SAID TOWN LIMITS, AND GRANTING TO ALL THE INHABITANTS OF SAID PROPERTY ALL THE RIGHTS AND PRIVILEGES OF OTHER CITIZENS AND BINDING SAID INHABITANTS BY ALL OF THE ACTS, ORDINANCES, RESOLUTIONS, AND REGULATIONS OF SAID TOWN; AND ADOPTING A SERVICE PLAN, subject to legal review.

8. STREETS UPDATE - JOSE MUÑOZ, TOWN ENGINEER:

Jose Muñoz, Guzman and Muñoz Engineering stated that they will star surveying and will be sharing and adding information to the plan.

The first phase includes Santa Ana Avenue and Plantation Drive, they will be working on a schedule to advertise for bids on the construction projects. They will then be looking at the addition of headers and maintenance projects.

Alderman Vera asked about the phases and what projects were to be done. Mr. Munoz stated that the second phase would include the cul-de-sacs. They will need to work on street elevations for the water lines and work with VMUD#2 to proceed with the work.

Mayor Guerrero stated that item # 9 will be reviewed later in the agenda.

14. February 2025 POLICE REPORT - POLICE CHIEF:

Police Chief Robert Tyler presented the February 2025 Police Report. The Board asked about amending the golf cart ordinance to include for drivers to be licensed, and to be reviewed by legal.

9. CONSIDERATION/ACTION ON FARMERS MARKET AGREEMENT RENEWAL:

Bonnie Emerson stated that there were no changes to the current Farmer's Market agreement. The only thing that could change was the time that the event is to be held because of the weather. Alderman Ricoy stated if they could add temporary signs and send out alerts to announce the event ahead of time so that they are able to get more attendees.

Motion was made by Alderman Day, and seconded by Alderman Ricoy, to approve the agreement renewal for the Farmer's Market for one year and to have the market up to twice a month on Sundays with times subject to change depending on the weather.

A RESOLUTION OF THE BOARD OF ALDERMEN OF THE TOWN OF RANCHO VIEJO, TEXAS, AUTHORIZING BANK ACCOUNTS AND DEPOSITORY HERETOFORE ESTABLISHED AND AUTHORIZING CERTAIN PERSONS TO SIGN CHECKS AND OTHER NECESSARY TRANSACTIONS FOR SAME

WHEREAS, it is necessary that accounts be maintained at Plains Capital Bank for the payment of expenses of the Town and the deposit of monies received; and

ORDINANCE NO.	

AN ORDINANCE OF THE TOWN OF RANCHO VIEJO, TEXAS AMENDING CHAPTER 62 "TRAFFIC AND MOTOR VEHICLES", ARTICLE V GOLF CARTS, SECTION 62 BY AMENDING SECTION 62-100, DEFINITIONS, AND AMENDING SECTION 62-101, USE OF GOLF CARTS, PROVIDING FOR A PENALTY, PROVIDING FOR AN EFFECTIVE DATE, AND PUBLICATION IN CAPTION FORM

WHEREAS, for the health, safety, and welfare of the residents of the Town of Rancho Viejo, Texas, an ordinance authorizing the use of golf carts are deemed to be in the best interest of the residents of the Town of Rancho Viejo, Texas (the "Town"); and

WHEREAS, an ordinance for the use of golf carts on Town streets aligns with the Rancho Viejo Vision Statement 2020, adopted January 2007, which states that its predominant objectives are, in part, to retain Rancho Viejo's small/resort town atmosphere, to protect the quality of life at the population increases, and to maintain the safety of the Rancho Viejo residents; and

WHEREAS, golf cart use can help to reduce overall emissions and their use is an ecofriendly or "green" alternative to traditional passenger vehicles; and

WHEREAS, the Board of Aldermen passed, adopted, and approved Ordinance No. 216 on March 17, 2015 and Ordinance No. 216A on March 24, 2015 to authorize and regulate golf cart use on public roadways and in parking areas of the Town (the "Golf Cart Ordinance"); and,

WHEREAS, given that a golf cart is considered a "motor vehicle" under the Texas Transportation Code, the Board of Aldermen wishes to amend the Golf Cart Ordinance to specifically reflect the Texas Transportation Code's requirement that all drivers of golf carts on public roadways must have a driver's license and such golf carts must each display a license plate;

NOW, THEREFORE, pursuant to the authority granted by the Section 551.404 of the Texas Transportation Code, BE IT ORDAINED BY THE BOARD OF ALDERMEN OF THE TOWN OF RANCHO VIEJO, TEXAS, THAT:

Section 1: Section 62-100 of Chapter 62, Article V "GOLF CARTS" is amended to read, as follows:

"In this Article:

- (A) "Golf Cart" means a motor vehicle designed by the manufacturer primarily for use on a golf course.
- (B) A "Public Roadway" includes a road, street, way, thoroughfare, or bridge:
 - a. That is within the city limits of the Town of Rancho Viejo;
 - b. That is for the use of vehicles; and,
 - c. That is not privately owned or controlled."

Section 2: Section 62-101 of Chapter 62, Article V "GOLF CARTS" is amended to read, as follows:

"Subject to Section 62-103, Prohibited Acts, and applicable provisions of the Texas Transportation Code, as may be amended from time to time, a Golf Cart may only be used on a Public Roadway if:

- 1. The Public Roadway has a posted speed limit of not more than 35 miles per hour;
- 2. All drivers of Golf Carts have a driver's license in accordance with TEX. TRANSP. CODE § 521.021 to operate a motor vehicle on the Public Roadway;
- 3. The Golf Cart displays a license plate in accordance with Tex. TRANSP. CODE § 551.402;
- 4. All drivers of Golf Carts shall abide by all traffic regulations applicable to vehicular traffic when using the Public Roadway and parking areas of the Town;
- 5. All passengers of a Golf Cart must be seated at all times while the Golf Cart is in motion; and,
- 6. The Golf Cart has the following equipment properly attached:
 - a. Headlamps;
 - b. Taillamps;
 - c. Reflectors;
 - d. Parking brake;
 - e. Mirrors; and,
 - f. A slow moving vehicle emblem."
- Section 3: That all ordinances or parts of ordinances in conflict with the provisions of this ordinance are hereby repealed.
- Section 4: That the Code of the Town of Rancho Viejo, as amended, shall remain in full force and effect, save and except as amended by this ordinance.
- Section 5: That if any section, paragraph, sentence, clause, phrase, or word of this ordinance is declared unconstitutional or invalid for any purpose, the remainder of this ordinance shall not be affected thereby and to this end the provisions of this ordinance are declared to be severable.
- Section 6: That it is hereby found and determined that the meetings at which this ordinance was passed were open to the public, as required by Section 551.001 et. seq., Texas Government Code, and that advance public notice of the time, place, and purpose of said meetings was given.

- Section 7: This Ordinance shall become effective from and after the date of its passage and publication, and it is accordingly so ordained.
- Section 8: Any fines or penalties or relief imposed by the Code of the Town of Rancho Viejo for violation of Chapter 62 shall continue to apply.
- Section 9: All ordinances and parts of ordinances in conflict with this Ordinance are hereby repealed to the extent of any conflict.

RESOLUTION OF THE TOWN OF RANCHO VIEJO, TEXAS SUPPORTING HB 4050 FILED BY STATE REPRESENTATIVE JANIE LOPEZ IN SUPPORT OF A STUDY BY THE TEXAS DEPARTMENT OF TRANSPORTATION TO INCORPORATE DRAINAGE IN ITS PLANNING PROCESS.

WHEREAS, municipalities, counties, and drainage districts have enjoyed working with the Texas Department of Transportation as it works to build and to upgrade its state highways;

WHEREAS, municipalities, counties, and drainage districts recognize their responsibilities in funding drainage projects;

WHEREAS, the importance of investing in drainage and in ensuring that all governmental entities are partaking in the planning of drainage improvements is vitally important;

WHEREAS, working collaboratively on drainage improvements helps, in the long run, to save taxpayers' money and helps to better plan drainage projects on state highways;

WHEREAS drainage planning is fundamental not only to the quality of life of citizens throughout the State of Texas but also to mitigating flooding;

WHEREAS, drainage planning, however, should not be limited to municipalities and drainage districts but also include the Texas Department of Transportation;

WHEREAS, State Representative Janie Lopez has filed HB 4050 to mandate that the Texas Department of Transportation study its current planning process to ensure that drainage is included in this process;

WHEREAS, the Town of Rancho Viejo supports State Representative Janie Lopez and her efforts to ensure that planning be part of the transportation planning process of the Texas Department of Transportation;

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF ALDERMEN, OF THE TOWN OF RANCHO VIEJO, TEXAS THAT IT:

SECTION 1. SUPPORTS HB 4050 filed by State Representative Janie Lopez for a study to be initiated by the Texas Department of Transportation to incorporate drainage in its planning process.

SECTION 2. SUPPORTS the efforts by State Representative Janie Lopez to get HB 4050 placed on the agenda of the Committee on Transportation.

SECTION 3. URGES the Committee on Transportation to act favorably on this legislation for this study.

DEADLINES

A completed application must be received at least 30 days before the event: 45 days is recommended to ensure adequate planning time. If you plan to serve alcohol at your event, we recommend that you submit a completed application 90 days in advance to ensure adequate planning time.

PAYMENT

Fees and deposits are due within 48 hours upon notification of approval. Checks may be made payable to the Town of Rancho Viejo. First Amendment type activities are exempt from fees. "First Amendment Activity" means an expressive and associative activity on public right-of-way or public property that is protected by the United States and Texas Constitutions, including speech, press, assembly, and the right to petition, but does not include commercial advertising, revenue-generating activities, fundraising, or a parade as defined herein.
