REQUEST FOR A VARIANCE BY NARCEDALIA G. DE GARCIA, OWNER, LOT 43A, SECTION 7, 1704 TESORO, RANCHO VIEJO, TEXAS, TO PROVIDE FOR A VARIANCE FROM THE ZONING ORDINANCE (ORDINANCE NO. 18 AS AMENDED), ARTICLE IV, SECTION 7 - ADDITIONAL SETBACK FOR STRUCTURES OVER 20 FEET - NOT TO INCREASE THE SIDE YARD SETBACKS BY SIX (6) INCHES FOR EACH FOOT ABOVE 20 FEET. THIS IS FOR THE CONSTRUCTION OF A NEW HOME.

(Ordinance No. 18 as amended), Article IV, Section 1b - to be less than the 25 feet of the rear property line for the construction of an out building in progress, as per the plot plan and drawings submitted.

REQUEST FOR VARIANCES BY MRS. FRANCES RUSTEBERG, RANCHO VIEJO COMMUNITY IMPROVEMENT ASSOCIATION, INC. FOR LOTS 10, 11, 12, AMENDED PLAT OF SANDRA SUE ESTATES, ON ANGELITAS, TO PROVIDE FOR VARIANCES FROM THE ZONING ORDINANCE (ORDINANCE NO. 18, AS AMENDED) ARTICLE IVD, FENCE AND WALL REGULATIONS - SECTION 2A - FOR A FENCE TO BE HIGHER THAN 6 FEET IN HEIGHT; AND ARTICLE IV, SECTION 1C, ARTICLE IVD, SECTION 3A AND 3B - FOR A FENCE TO BE CLOSER THAN 25 FEET TO THE EDGE OF THE STREET. THIS FENCE IS TO ENCLOSE THE PARK.

Mrs. Frances Rusteberg spoke about the fence to be installed around the children's park. Mr. Zebrowski closed the public hearing after everyone had an opportunity to speak on the matter.

Motion was made by Mr. Ortiz, seconded by Mrs. Isbell, and unanimously carried, to grant the variance request by Mrs. Frances Rusteberg, Rancho Viejo Community Improvement Association, Inc. for Lots 10, 11, 12, amended Plat of Sandra Sue Estates, on Angelitas, to provide for variances from the Zoning Ordinance (Ordinance No. 18, as amended) Article IVD, Fence and Wall Regulations - Section 2a - for a fence to be higher than 6 feet in height but not to exceed 8 feet in height and Article IV, Section 1c, Article IVD, Section 3a and 3b - for a fence to be closer than 25 feet to the edge of the street. This fence is to enclose the park.
