AEP PRESENTATION ON ELECTRIC SYSTEM AND RECENT OUTAGES:

Mayor Medrano noted that there was a Public Meeting scheduled for March 22, 2011 at 6:00 P.M. to discuss the Texas Safe Shelter Initiative program and get feedback from the Board and residents.

F.M. 1732 DRAINAGE PROJECT UPDATE:

Mayor Medrano reported that Cameron County personnel had installed culvert pipes on F.M. 1732 to alleviate the drainage problem in Rancho Viejo at Carmen and F.M. 1732. Mr. Mike Ortiz volunteered his time and equipment to make swells on his property to drain into the county irrigation ditch.

PUBLIC HEARING ON TEXAS SAFE SHELTER INITIATIVE PROGRAM (TSSI) - COMMUNITY SAFE ROOM CONSTRUCTION PROJECT:

Mayor Medrano opened the public hearing on the Texas Safe Shelter Initiative Program with a brief presentation on the Community Safe Room Construction project. This project would be to construct a 5,000 square foot dome building to be used as a shelter in extreme weather events at a cost of approximately \$600,000 with the federal government paying 75% of the cost. When not in use as a shelter, it could be used for a gymnasium, meeting space or to hold public gatherings. Several members of the audience stated their opinion on this project, the majority of which were not in favor of the project. After everyone was given an opportunity to speak on the matter, motion was made by Alderman Lackner, seconded by Alderman Rafac, to close the public hearing.

CONSIDERATION/ACTION ON GRANT APPLICATION FOR TEXAS SAFE SHELTER INITIATIVE PROGRAM (TSSI) - COMMUNITY SAFE ROOF PROJECT:

Alderman Rafac spoke on the matter and said he was against submitting the application for this program. Alderman Lackner also noted that he was opposed to this project.

Mayor Medrano asked for a motion to approve submittal of the grant application for the Texas Safe Shelter Initiative Program (TSSI) - Community Safe Roof Project but the item died for lack of a motion.

Item #12: Update on Tax Note Series 2005

At earlier board meetings, I explained that the Town was in the process of discussing the Town Hall Bond Note with IBC, which owns the note. Well, based on our discussions in which the Town asked for a lower interest rate, the IBC board considered the request and thus approved action to lower the interest rate, yet another time within the last twelve months, this time from 4.75% to 4%. Please note that IBC was not under any obligation to do so. The initial rate reduction occurred in March 2010 when it was lowered from 5.25% to 4.75%. The current interest rate took effect at the time of the IBC board approval in February 24, 2011 and will be effective until the note matures in November 2012. With the May 2010 payment, the Town saved \$604.16----this savings has gone against the principal in an effort to close the note quicker. Altogether, since the initial rate reduction, the Town saved, \$2,270.34; the town will save approximately \$11,000 between May 2011 and November 2012 for a grand total of about \$14,000.00.

The original intent of the Board of Aldermen in 2005 was to amortize the entire note over 20 years or so. However, this was not possible because Texas law allows a maximum amortization of 7 years for a town with a financial situation like ours. Thereafter, it was understood by the Town and IBC that the note would renew at about the same payment.

The ordinance adopted by the Board left options for the Town. At maturity, if the Town wanted, we could shop around with other banks to seek a rate of 65% of the Wall Street prime. Sounds very attractive taken in a vacuum, but it is not that simple. For starters, the Town must package the Bond Note for consideration by other banks. The packaging process is not free--there is a cost involved. The rating fee could cost anywhere from \$20,000 to \$40,000. Our note is relatively small, and because of this fact a rating company would, in all likelihood, charge above the lower range. A prospectus would have to be written at a cost of \$10,000 to \$15,000. A full-fledged tax opinion from a bond attorney would be required and would come at a cost of \$6,000 to \$10,000. Adding the latter estimates, the Town would be facing a cost range of \$36,000 to \$65,000---again, with the latter figure being more realistic because of the relatively small amount. And if this is not enough, banks are not obligated in any way to agree to 65% of the prime. As a matter of fact, the ordinance states that the town should seek a rate of 65% of prime but not to exceed 15%. In all probability because banks are not in the business of taking high risks and losing money, 65% of prime would not happen. Furthermore, the Town enjoys a very favorable depository agreement with IBC. This is no accident---the Board intended it to be that way and so it was written into ordinance. The IBC was the lone bank willing to entertain the note and submit a bid as depository---no other bank submitted bid. The Town enjoys not only a favorable depository agreement---we enjoy a good relationship that has enabled us to obtain expeditious loans for our security cameras and a police truck with reasonable interest rates. These kinds of requests would still be in the processing phase with any other bank.

Given the current market, the Town would be taking a risk of ending up with a more expensive rate for the remainder of the note, and would be lucky to come out even. Ladies and

gentlemen, Rancho Viejo is doing well in its financial dealings with the IBC and we enjoy a good working relationship.
