A RESOLUTION ADOPTING THE LOWER RIO GRANDE VALLEY REGIONAL INTEROPERABILITY COMMUNICATION PLAN/STANDARD OPERATING PROCEDURES (SOP)

WHEREAS, the Town of Rancho Viejo is working with local governments and other in equipment standardization; and

WHEREAS, the health, safety and welfare of public safety in the Lower Rio Grande Valley is threatened by a variety of natural and technological hazards including terrorism; and

WHEREAS, the Department of Homeland Security and the State of Texas, in coordination with Council of Governments in Texas seek to address regional standardization of training, equipment, and exercise; and

WHEREAS, the Town of Rancho Viejo is the appropriate agency of local governments to coordinate the aforementioned assistance with guidance and leadership from the Regional Communications Committee and the State of Texas.

NOW, THEREFORE, BE IT RESOLVED by the Board of Aldermen of the Town of Rancho Viejo, Texas that:

- Section 1. The Lower Rio Grande Valley Regional Interoperability Communication Plan / Standard Operating Procedures (SOP's) proposed by the Lower Rio Grande Valley Development Council be endorsed as submitted by the Regional Communications Committee.
- Section 2. This resolution will also serve as the official review and adoption by the local government as requested by the Lower Rio Grande Valley Development Council.
- Section 3. This resolution shall be in effect immediately upon its adoption.

Dear Mayor Roberto Medrano,

As you are aware, during an incident or disaster whether natural or man-made, first responder agencies must establish reliable lines of radio communication regardless of radio brand or frequency. For this reason, achieving radio interoperability communications and most importantly the standardization of current radio communication systems has been a top priority for federal, state, and local agencies.

The Lower Rio Grande Valley Development Council (LRGVDC) Homeland Security Advisory Committee (HSAC) which is comprised of local Police, Fire and EMC representatives have worked cooperatively to develop the attached Lower Rio Grande Valley Regional Interoperability Systems -Standard Operating Procedures (SOP) and Regional Interoperable Communications Plan (RICP) document for all cities within the counties of Cameron, Hidalgo and Willacy to adopt and practice. The purpose of this SOP and RICP is to delineate the authority, roles, and procedures for city and county agency supervisory personnel to use the interjurisdictional Texas Interoperability Channel Plan. Rest assured, this new SOP and RICP is not meant to replace or supersede any existing policies and procedures that your jurisdiction currently has in place.

At the request of the LRGVDC-HSAC, please review and consider the adoption of the attached SOP and RICP no later than December 31, 2011. For your convenience, I have attached a sample of a resolution and the SOP and RICP in electronic format and also a hard copy for your next regularly scheduled City Commission meeting to review and adopt. After ten days, the Mayor and Police Chief will review the offers and accept the highest one and execute the sale of the vehicles.

This procedure is being used to expedite the sale in an effort not to lose the buyer.

# Town of Rancho Viejo Alert Network Overview

Instantaneous and proactive communication from the Town Hall and local law enforcement to you

The Alert Network allows the Town of Rancho Viejo to instantly update you about town meetings, crimes, emergencies and other important information.

All Alerts are delivered via **e-mail** and are also available via **text message** on your cell phone.

- Citizen Alerts inform all registered users of Town information and public safety concerns in your area. The Alerts contain information about meetings, crime trends, description of suspects, missing persons, as well as advice on personal safety, and how to safeguard property.
- **Business Alerts** are targeted to specific business types, so your business will receive information about issues that are pertinent to your business type.
- Case Alerts allow law enforcement to automatically disseminate information about open cases to all registered Citizen Observer users.
- Watch Group Alerts allow the Town Hall to send targeted alerts to specific neighborhoods with information concerning their immediate area.
