The average taxable value of a residence homestead in TOWN OF RANCHO VIEJO last year was \$177,360. Based on last year's tax rate of \$0.391934 per \$100 of taxable value, the amount of taxes imposed last year on the average home was \$695.13.

The average taxable value of a residence homestead in TOWN OF RANCHO VIEJO this year is \$179,389. If the governing body adopts the effective tax rate for this year of \$0.390081 per \$100 of taxable value, the amount of taxes imposed this year on the average home would be \$699.76.

If the governing body adopts the proposed tax rate of \$0.418717 per \$100 of taxable value, the amount of taxes imposed this year on the average home would be \$751.13.
