ORDINANCE NO. 62R

AN ORDINANCE OF THE TOWN OF RANCHO VIEJO, TEXAS AMENDING ORDINANCE NO. 62P REAPPOINTING MEMBERS OF THE BUILDING COMMITTEE

WHEREAS, the Town of Rancho Viejo has heretofore enacted Ordinances Nos. 62A through 62Q which provided the requirements for obtaining building permits and the fees and charges for the issuance of said building permits and established a Building Committee which committee members are appointed by the Board of Aldermen; and

WHEREAS, the Board of Aldermen of said Town wish to reappoint members of the Building Committee.

#9 Consideration/Action on a Resolution of the Board of Aldermen of the Town of Rancho Viejo, Texas Authorizing the Continuation of Debt Bank Account Established, Heretofore Renaming the Debt Bank Account, and Authorizing Certain Persons to Sign Checks for Same

RESOLUTION NO.

A RESOLUTION OF THE BOARD OF ALDERMEN OF THE TOWN OF RANCHO VIEJO, TEXAS, AUTHORIZING THE CONTINUATION OF DEBT BANK ACCOUNT HERETOFORE ESTABLISHED, RENAMING THE DEBT BANK ACCOUNT, AND AUTHORIZING CERTAIN PERSONS TO SIGN CHECKS FOR SAME

WHEREAS, it is necessary that the debt account be maintained at International Bank of Commerce for the payment of expenses of the Town and the deposit of monies received; and

WHEREAS, it is necessary that certain persons be authorized to sign checks for the withdrawal of funds from said accounts;

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF ALDERMEN OF THE TOWN OF RANCHO VIEJO, TEXAS THAT:

Section 1. That the debt account be renamed Debt Service Fund.

Section 2. Required on all transactions shall be two signatures, one of these to be a primary signer which is the Town Administrator or Mayor. Secondary signers are any one of the other aldermen of the Town of Rancho Viejo.
