6. JULY 2016 FINANCIAL REPORT - TOWN ADMINISTRATOR:

8. PRESENTATION BY FERNANDO A. MARTINEZ ON THE RAUL ALCALA BROWNSVILLE/SOUTH PADRE ISLAND GRAN FONDO/CHALLENGE 2016:

Mr. Fernando A. Martinez gave a presentation and thanked the Town for last year's participation. The challenge was very successful and they are planning on having about 750 riders this year on November 6, 2016. Mr. Martinez asked for the Town's support, the Mayor and the Board are looking forward to this year's event.

9. CONSIDERATION/APPROVAL OF A RESOLUTION TO ADOPT THE LOWER RIO GRANDE VALLEY ACTIVE TRANSPORTATION AND ACTIVE TOURISM PLAN, THE ACTIVE PLAN, AS A PART OF THE RANCHO VIEJO COMPREHENSIVE PLAN:

Ms. Eva Garcia presented a slideshow of the regional network plan in Cameron County, there are several cities already involved with many plans to help attract tourism to our area. Motion was made by Alderman Lucio, seconded by Alderwoman Carr, and unanimously carried, to approve Resolution No. 286 - A RESOLUTION TO ADOPT THE LOWER RIO GRANDE VALLEY ACTIVE TRANSPORTATION AND ACTIVE TOURISM PLAN, THE ACTIVE PLAN, AS A PART OF THE RANCHO VIEJO COMPREHENSIVE PLAN.

10. CONSIDERATION/APPROVAL OF A RESOLUTION TO ENDORSE AND SUPPORT THE DEVELOPMENT OF A HIKE AND BIKE TRAIL THROUGH THE BAHIA GRANDE UNIT OF THE UNITED STATES FISH AND WILDLIFE SERVICE'S LAGUNA ATASCOSA NATIONAL WILDLIFE REFUGE:

Motion was made by Alderman Lucio, seconded by Alderman Vera, and unanimously carried, to approve Resolution No. 287 - A RESOLUTION TO ENDORSE AND SUPPORT THE DEVELOPMENT OF A HIKE AND BIKE TRAIL THROUGH THE BAHIA GRANDE UNIT OF THE UNITED STATES FISH AND WILDLIFE SERVICE'S LAGUNA ATASCOSA NATIONAL WILDLIFE REFUGE.

11. CONSIDERATION/ACTION OF DEPOSITORY APPLICATIONS AND DEPOSITORY CONTRACT FOR TWO YEARS WITH THE POSSIBILITY OF THREE ONE YEAR EXTENSIONS AT THE TOWN'S OPTION:

After review of this item, Mayor Rathbun recommended approval of a depository contract with Texas Regional Bank. Town Administrator, Fred Blanco asked about transfer costs for the current 4 bank accounts. Nathan Pierce, Town Attorney asked about the wording on the term of the contract. Ms. Beverly Speer, Senior Vice President for Texas Regional Bank stated that there would be no transfer costs and they would work on the wording to be not more than 5 years total. Motion was made by Alderwoman Guerrero, seconded by Alderman Vera, and unanimously carried, to approve the Depository Contract with Texas Regional Bank for 2 years with the possibility of three one year extensions at the Town's option.

19. CONSIDERATION/ACTION OF EMERGENCY MEDICAL SERVICES CONTRACT:

Chief Carlos Elizondo with the Brownsville Fire Department gave a brief update on the Emergency Medical Services that the Fire Department provides as a dual responsibility department. Chief

Elizondo also mentioned the different distances between their locations and the locations from our current provider out of Harlingen/San Benito. He also mentioned that there is a plan for a projected site off of F.M. 511 closer to Rancho Viejo. Chief Bill Aston with the South Texas Emergency Care Foundation, Inc. answered questions from the Board and then made his presentation about their proposed five year ambulance contract.

Motion was made by Alderwoman Carr, seconded by Alderman Lucio, to approve the Emergency Medical Services Contract with the Brownsville Fire Department for a term of five years at no cost subject to legal approval and revisions. Motion passed with the following vote:

12. CONSIDERATION/ADOPTION OF BUDGET ORDINANCE FOR FISCAL YEAR OCTOBER 1, 2016 TO SEPTEMBER 30, 2017:

Motion was made by Alderwoman Guerrero, seconded by Alderman Lucio, and unanimously carried, to pass, adopt and approve Ordinance No. 220 - AN ORDINANCE OF THE BOARD OF ALDERMEN APPROVING AND ADOPTING THE BUDGET FOR THE TOWN OF RANCHO VIEJO, TEXAS, AS PREPARED BY THE MAYOR FOR THE FISCAL YEAR 2016 - 2017.

13. CONSIDERATION/RATIFICATION OF THE PROPERTY TAX (REVENUE) INCREASE REFLECTED IN THE BUDGET FOR FISCAL YEAR OCTOBER 1, 2016 TO SEPTEMBER 30, 2017:

Motion was made by Alderwoman Carr, seconded by Alderwoman Guerrero, and unanimously carried, to ratify that this budget will raise more revenue from property taxes than last year's budget by \$126,465 or 12.628784%, and of that amount \$16,410 is tax revenue to be raised from new property added to the roll this year.

14. CONSIDERATION/ADOPTION OF ORDINANCE TO ESTABLISH AD VALOREM TAX RATE TO PROVIDE FOR BUDGET EXPENSES FOR FISCAL YEAR 2016 - 2017:

Motion was made by Alderwoman Truan, seconded by Alderwoman Guerrero, and unanimously carried, that the property tax rate be increased by the adoption of the tax rate of \$0.450000, which is effectively a 8.117707% decrease in the tax rate; and to pass, adopt and approve Ordinance No. 221 - AN ORDINANCE ESTABLISHING THE AD VALOREM AND PERSONAL PROPERTY TAX RATE FOR THE TAX YEAR 2016, SETTING THE ASSESSED VALUATION AT ONE HUNDRED (100%) PERCENT OF THE FAIR MARKET VALUE, PROVIDING FOR A HOMESTEAD EXEMPTION OF \$5,000, PROVIDING FOR DISCOUNTS IN THE EVENT OF EARLY PAYMENT, AND PROVIDING FOR PENALTY AND INTEREST IN ACCORDANCE WITH STATE LAW AND PROVIDING FOR SEVERABILITY. The total tax rate adopted was \$0.450000.

15. CONSIDERATION/ACTION ON MUNICIPAL JUDGE CONTRACT:

Motion was made by Alderwoman Truan, seconded by Alderwoman Guerrero, and unanimously carried, to approve the Municipal Judge Contract with Ricardo M. Adobbati for a one year term that may be extended for additional one year terms upon mutual consent of both parties.

16. CONSIDERATION/ACTION ON CLEANING SERVICES CONTRACT:

Motion was made by Alderwoman Guerrero, seconded by Alderwoman Carr, and unanimously carried, to approve the Cleaning Services Contract with Maria Ponce for a one year term.
