7. CONSIDERATION/ACTION ON EXTENSION OF BANK DEPOSITORY CONTRACT WITH TEXAS REGIONAL BANK.

Mayor Rathbun recommended the Extension of the Bank Depository Contract with Texas Regional Bank for the first, one year extension.

Motion was made by Alderman Vera, seconded by Alderman Truan, and unanimously carried, to approve the extension of Bank Depository Contract with Texas Regional Bank, this is the first, one year extension.

8. CONSIDERATION OF BIDS AND AWARD OF CONTRACT FOR COMMON AREA MAINTENANCE:

Mayor Rathbun mentioned that the Town received 2 bids. The bid opening was held on July 31, 2018 and the Mayor recommended that one bid be rejected due to irregularities. The areas to be maintained remained the same except for adding one monument at the Cortez entrance and one monument at the Carmen and Frontage entrance, for a total of two new monuments.

Motion was made by Alderman Salinas, seconded by Alderman Truan, and unanimously carried, to reject the bid that was not responsive and to award the Common Area Maintenance contract to Complete Landscape Management for a two year term in the amount of \$51,120.00 per year.

9. CONSIDERATION/APPROVAL OF FIRE PROTECTION CONTRACT WITH THE CITY OF BROWNSVILLE:

Mayor Rathbun mentioned that the proposal was for the same amount as the current contract, \$30,000 per year to be paid as \$7,500 per quarter. It is a three year contract to remain the same, the only change is the name of the city secretary. Motion was made by Alderman Tumlinson, seconded by Alderman Salinas, and unanimously carried, to table this item for review of an actual contract at next meeting.

Alderman Guerrero arrived at 6:35 P.M.

10. STREET COMMITTEE REPORT:

Alderman Guerrero mentioned that there were no new developments. VMUD#2 has acquired funding for their repairs and the engineer is working together with them and the Street Committee. They are moving forward with a mutual agreement for funding and commencement of construction for both entities.

11. CONSIDERATION/ACTION ON AN MOU WITH VMUD#2 REGARDING A JOINT WATER/WASTEWATER AND STREET RECONSTRUCTION PROJECT:

Legal counsel, Mr. Daniel Rentfro, Jr. answered several questions from the Board. Alderman Guerrero and Alderman Vera have met with the engineer regarding joint work with VMUD #2.

Motion was made by Alderman Salinas, seconded by Alderman Guerrero, and unanimously carried, to approve the MOU with VMUD#2 Regarding a joint water/wastewater and street reconstruction project, subject to legal review.

12. HUMAN RESOURCE COMMITTEE REPORT:

Alderman Salinas gave a brief update, there was nothing new to report. She has met with the committee members individually and informally several times. They have worked on collecting data

from many different entities to come up with HR policies. They are working on a rough draft, once it is ready they will present to the Board of Aldermen.

Dear Fellow Texans:

Today marks the 17th anniversary since our nation, our people, and our very way of life came under attack by terrorists on American soil. With four hijacked planes and evil intentions, terrorists killed nearly 3,000 Americans as they crashed into our buildings and fields in New York, Pennsylvania, and Virginia.

Seventeen years later, it still makes me proud that in the face of tragedy, American patriotism prevailed above evil. We lowered our heads in prayer and rose up to serve our fellow man. We bound together as they tried to tear us apart. And we reflected on how very fortunate we are to live in the land of the free and the home of the brave.

POLICE

Existing Services: None

Services to be Provided: Currently, the area is under the jurisdiction of the Cameron County Sheriff's Office. However, upon annexation, the Town of Rancho Viejo Police Department will extend regular and routine patrols to the area. It is anticipated that the implementation of police patrol activities can be effectively accommodated within the current budget and staff appropriation.

BUILDING INSPECTION

Existing Services: None

Services to be Provided: The Building Inspection Department will provide Code Enforcement Services upon annexation. This includes issuing building, electrical and plumbing permits for any new construction and remodeling, and enforcing all other applicable codes which regulated building construction within the Town of Rancho Viejo, Texas.

PLANNING AND ZONING

Existing Services: None

Services to be Provided: The Planning and Zoning Department's responsibility for regulating development and land use through the administration of the Town of Rancho Viejo's Zoning Ordinance will extend to this area on the effective date of the annexation. The property will also continue to be regulated under the requirements of the Town of Rancho Viejo's Subdivision Ordinance. These services can be provided within the department's current budget.

HEALTH DEPARTMENT- HEALTH CODE ENFORCEMENT SERVICE

Existing Services: None

Services to be Provided: The Town of Rancho Viejo will implement the enforcement of the Town's health ordinances and regulations on the effective date of the annexation. Such services can be provided within the current budget appropriation. In addition, animal control services will be provided to the area as needed.

STREET

Existing Services: None

Services to be Provided: Maintenance to the street facilities will be provided by the Town of Rancho Viejo upon the effective date of the annexation and provided that such street facilities to be maintained by the Town of Rancho Viejo are first dedicated to the Town of Rancho Viejo. This service can be provided within the current budget appropriation.

STORM WATER MANAGEMENT

Existing Services: None

Services to be Provided: Developers will provide storm water drainage at their own expense and will be inspected by the Olmito Water Supply Corporation at time of completion. The Olmito Water Supply Corporation will then maintain the drainage upon approval.

STREET LIGHTING

Existing Services: None

Services to be Provided: The Town of Rancho Viejo will coordinate any request for improved street lighting with the local electric provider in accordance with standard policy.

TRAFFIC ENGINEERING

Existing Services: None

Services to be Provided: The Town of Rancho Viejo will be able to provide, after the effective date of annexation, any additional traffic control devices.

WATER SERVICE

Existing Services: None

Services to be Provided: Water service to the area will be provided in accordance with the applicable codes by the Olmito Water Supply Corporation. When other property develops in the adjacent area, water service shall be provided in accordance with the agreement between the Developer and the Olmito Water Supply Corporation.

SANITARY SEWER SERVICE

Existing Services: None

Services to be Provided: Sanitary sewer service to the area of proposed annexation will be provided in accordance with applicable codes. When property develops in the adjacent areas, sanitary sewer service shall be provided in accordance with the present extension ordinance. Extension of service shall comply with applicable codes and ordinances.

SOLID WASTE SERVICES

Existing Services: None

Services to be Provided: Solid Waste Collection shall be provided to the area of annexation in accordance with the present ordinance. Service shall comply with existing policies, beginning with occupancy of structures.

MISCELLANEOUS

All other applicable municipal services will be provided to the area in accordance with the Town of Rancho Viejo's established policies governing extension of municipal services to newly annexed areas.

COUNTY OF CAMERON §

CONTRACT

This agreement is made and entered by and between the Town of Rancho Viejo (Rancho Viejo) and the City of Brownsville (Brownsville), both municipal corporations located in Cameron County, Texas, acting by and through their respective undersigned Mayors, both Mayors having been authorized to execute this agreement upon an affirmative majority vote of their respective governmental bodies acting pursuant to the Interlocal Cooperation Act codified in Chapter 791 of the Texas Government Code.

In consideration of the Mutual Covenants, Agreements and benefits to both parties, it is AGREED as follows:

I. PROVISION OF SERVICES

During the term of this Agreement, BROWNSVILLE agrees to furnish fire fighting services to areas located within RANCHO VIEJO. Such services shall only include those required for grass fires, structure fires and/or vehicle fires.

II. COMPENSATION

Rancho Viejo AGREES TO PAY TO Brownsville the sum \$30,000 per annum for the fire fighting services referenced in Section I.

Compensation during periods of extension shall be at a pro rata amount of compensation set forth in section II.

Payments for said services shall be made in equal quarterly installments in advance of the service period. Payments shall be due as follows:

October 1, 2018, 2019, 2020	\$7,500.00
January 1, 2019, 2020, 2021	\$7,500.00
April 1, 2019, 2020, 2021	\$7,500.00
July 1, 2019, 2020, 2021	\$7,500.00

It is agreed further that as a condition precedent to payment, BROWNSVILLE shall provide a written report summarizing the services rendered during the previous quarterly period, with said report listing all calls by date, location and nature made on behalf of RANCHO VIEJO.

III. TERM OF AGREEMENT

The term of this agreement shall be for three (3) years beginning on October 1, 2018 and terminating on September 30, 2021.

IV. TERMINATION/RENEWAL

If BROWNSVILLE does not intend to renew this contract under the same terms and conditions at the end of the term, BROWNSVILLE shall provide RANCHO VIEJO with written notice of its intent to not renew said contract. A notice of its intent not to renew shall be sent by United States Mail, Certified Mail Return Receipt Requested, no later than the 1st of August, 2021. This sixty (60) day notice is intended to allow RANCHO VIEJO sufficient time to secure an alternate fire protection service.

If RANCHO VIEJO does not intend to renew this contract under the same terms and conditions, RANCHO VIEJO shall provide BROWNSVILLE with written notice of its intent to not renew said contract. A notice of this intent shall be sent by United States Mail, Return Receipt Requested, no later than the first of August 2021.

In the event that neither City notifies the other City of its intent not to renew this contract under the same terms and conditions, this Contract will be renewed for an additional term of one year under the same terms and conditions as presently agreed upon in this instrument.

In the event re-negotiation of the contract is necessary and if such negotiations have not been completed on or before the end of the current term, both BROWNSVILLE and RANCHO VIEJO expressly agree to act in accordance with the terms and conditions of this Contract for a period of thirty days after the expiration of the current term. If during such time both parties fail to negotiate a new contract, the negotiation period shall terminate at the end of the thirteenth day of said period, however, the contract obligations of both parties shall be extended for an additional thirty day period beyond the end of the negotiation period to allow RANCHO VIEJO time to secure an alternate fire protection service. At the end of this second period, all obligations of BROWNSVILLE shall cease.

However, not withstanding the provisions above, this contract may be terminated at will by either party and termination shall be effective sixty (60) days from the date of notice is received by the other party. Such notice shall be sent by United States Mail, Return Receipt Requested.

V. INDEMNIFICATION

RANCHO VIEJO hereby agrees to and shall defend, protect and hold BROWNSVILLE harmless from any liability or damages for property damage or bodily injury, including death, which may arise from RANCHO VIEJO's negligent acts or omissions under this Agreement.

VI. MISCELLANEOUS

This Contract shall comprise the entire agreement between the parties hereto and any amendment shall be enforceable only after being reduced to writing, mutually executed by the parties hereto and attached hereto.

ORDINANCE NO.

AD VALOREM AND PERSONAL AN ORDINANCE ESTABLISHING THE TAX YEAR 2018, SETTING PROPERTY TAX RATE FOR THE ASSESSED VALUATION AT ONE HUNDRED (100%) PERCENT OF FAIR MARKET VALUE, PROVIDING FOR A HOMESTEAD EXEMPTION OF THE EVENT PROVIDING FOR DISCOUNTS IN \$5,000, FOR PENALTY AND PAYMENT, AND PROVIDING ACCORDANCE WITH STATE LAW AND PROVIDING FOR SEVERABILITY

NOW THEREFORE, BE IT ORDAINED BY THE BOARD OF ALDERMEN OF THE TOWN OF RANCHO VIEJO, TEXAS:

Section 1. There is hereby established a tax rate for the tax year 2018:

- \$.358909 Maintenance & Operation Tax Rate
- \$.091091 Debt Tax Rate
- \$.450000 Total Tax Rate

for each \$100.00 of assessed valuation of all ad valorem and personal property taxable under the laws of this State by the Town of Rancho Viejo.

THIS TAX RATE WILL RAISE MORE REVENUE AND OPERATIONS LAST THAN MATNTENANCE EFFECTIVELY TAX RATE TAX RATE. THE WILL MORE BY 3.956866 PERCENT AND WILL RAISE MORE FOR MAINTENANCE AND OPERATIONS ON A REVENUE \$100,000 HOME BY APPROXIMATELY \$13.66.

Section 2. There is hereby established an assessed valuation of one hundred (100%) percent of the fair market value of all real and personal property according to the certified tax rolls of the Town of Rancho Viejo.

Section 3. There is hereby granted a homestead exemption to qualified homeowners at the level of \$5,000 on the ad valorem tax for the tax year 2018.

Section 4. There is hereby granted a discount for early payment of the 2018 taxes which discount shall be equal to and the same as that granted by CAMERON COUNTY, the agency under contract to collect the taxes of this Town, said discount all being pursuant to State law.

Section 5. Any payment not timely made shall bear such penalty and interest as is provided by State law.

Section 6. If any section, paragraph, subdivision, clause, phrase, or provision of the Ordinance shall be adjudged invalid or held unconstitutional, the same shall not affect the validity of this Ordinance as whole or any part or provision thereof, other than the part so decided to be invalid or unconstitutional.

Section 7. This ordinance shall become effective upon passage.
