

RESOLUTION NO. 350A

A RESOLUTION TO AMEND THE ORDER OF ELECTION FOR THE MAY 2, 2020 ELECTION THAT WAS POSTPONED TO NOVEMBER 3, 2020

WHEREAS, an election is hereby ordered for the purpose of voting for three (3) Aldermen

NOW, THEREFORE, BE IT RESOLVED AND ORDERED BY THE BOARD OF ALDERMEN OF THE TOWN OF RANCHO VIEJO, TEXAS:

SECTION 1. That the Order of Election for the Town of Rancho Viejo, Texas, signed by Mayor Cyndie Rathbun and members of the Board of Aldermen dated August 11, 2020 for the election to be held on November 3, 2020, is hereby ratified and adopted in all respects.

SECTION 2. Said election is to be held on Tuesday, November 3, 2020, between the hours of 7:00 A.M. and 7:00 P.M. for qualified electors residing within the incorporated area of the Town of Rancho Viejo, and notice is further given that the polling place for such election is hereby designated as the Villareal Elementary School, 7770 E. Lakeside Blvd, Olmito, Texas, 78575. Method of Voting shall be by paper ballots, AutoMark Assist Terminal, Version 1.8.6.1 and DS200 Scanner (precinct counter), Version 2.12.2.0.

SECTION 3. Pursuant to the order of the Governor and advisories from the Texas Secretary of State, candidate filings for the May 2 election remain valid for the election to be held on November 3, but the filing period is not re-opened.


SECTION 4. The Town Secretary or his deputy is hereby appointed Clerk for Early Voting, which Early Voting shall be held at the Town Municipal Office located at 3301 Carmen Avenue in Rancho Viejo, Texas. The period to vote early in person at the Town Secretary's Office is:

Tuesday, Oct. 13 thru Friday, Oct 16	9 am to 7 pm
Saturday, Oct 17 thru Sunday, Oct 18	10 am to 5 pm
Monday, Oct 19 thru Friday, Oct 23	9 am to 7 pm
Saturday, Oct 24 thru Sunday, Oct 25	10 am to 5 pm
Monday, Oct 26 thru Wednesday, Oct 28	9 am to 7 pm
Thursday, Oct 29 thru Friday, Oct 30	8 am to 8 pm

Application to vote by mail shall be addressed to the Town Secretary, Town of Rancho Viejo, 3301 Carmen Avenue, Rancho Viejo, Texas 78575. Applications for ballot by mail or electronic submission of a scanned application must be received no later than the close of business on Friday, October 23, 2020. Electronic submission of a scanned application with an original signature shall be e-mailed to fblanco@ranchoviejotexas.com.

SECTION 5. Notice of the election order by the Mayor and Board of Aldermen of the Town of Rancho Viejo, Texas shall be given by publication in the SAN BENITO NEWS one time.
