3. INVOCATION AND PLEDGE

Alderwoman Guerrero led the group in the invocation and the pledge of allegiance to the American and Texas flag.

4. PUBLIC COMMENT

Motion to open public comment was made by Alderman Vera, seconded by Alderman Tumlinson and carried unanimously.

Alderman Grove took a moment address the Rancho Viejo Police Department and asked them to be mindful of the residents when enforcing the shelter in place order.

Motion to close public comment was made by Alderman Grove, seconded by Alderwoman Guerrero and carried unanimously.

5. APPROVAL OF MINUTES- REGULAR MEETING MARCH 10, 2020, SPECIAL MEETING MARCH 20, 2020

Mayor Rathbun noted that the both sets of minutes state that Alderwoman Guerrero gave the invocation when it was in fact delivered by Alderwoman Salinas. Mayor Rathbun further noted that she would like the minutes to reflect the dates included in the extension of the disaster declaration in the March 20, 2020 minutes. Alderman Tumlinson also pointed out that the minutes of March 20, 2020 had an error in the numbering of the pages.

Motion to approve the minutes with the aforementioned changes was made by Alderman Vera, seconded by Alderman Tumlinson and carried unanimously.

6. DISCUSSION/ACTION ON THE EXTENSION OF THE DISASTER DECLARATION FILED WITH THE OFFICE OF THE GOVERNOR

Motion to approve extension of the disaster declaration for 30 days starting April 20, 2020 to May 19, 2020 was made by Alderman Grove, seconded by Alderwoman Guerrero and carried unanimously.

7. PRESENTATION AND CONSIDERATION OF ACCEPTANCE OF AUDIT REPORT FOR FISCAL YEAR ENDING SEPTEMBER 30, 2019

The Audit report was presented by Alfred Vera of Cascos and Associates.

Motion to acknowledge the report was made by Alderwoman Salinas, seconded by Alderman Tumlison and carried unanimously.

8. COVID-19 UPDATE

Motion to move Item 8 out of sequence to discuss after Item 3 was made by Alderwoman Guerrero, seconded by Alderman Vera and carried unanimously.

Dr. James Castillo, Health Authority for Cameron County Public Health gave the Board and the Public an update on COVID-19 and answered questions that anyone had regarding the COVID-19 Virus.

9. POLICE CHIEF HIRING COMMITTEE REPORT

Mayor Rathbun reported that the applications for Chief of Police were sent to the Police Chiefs of San Juan, Victoria, and Kingsville to be scored based on qualifications. Based on the scores the applicants were narrowed down to the top ten. The ten candidates were contacted to ensure continued interest in the position. Alderwoman Guerrero wanted to extend credit to Laura Kaechele, Jaime Salazar, and Robert Gracia of the Hiring Committee for their involvement in developing the Rubric, that will be used to score the candidates and explained the Rubric's categories. Alderwoman Guerrero also advised that the committee is ready to move forward and start the process possibly by next Friday and narrow down to 3-5 candidates.

Alderman Tumlinson stated that Alderwoman Salinas' pick for Hiring Committee member Gilbert Elizondo will not be able to be part of the Hiring Committee. In turn, Alderwoman Salinas asked for a day to pick a new member.

Alderman Vera asked Mayor Rathbun for the top ten list selected by the Chiefs of Police previously mentioned.

10. STREET COMMITTEE REPORT

Alderwoman Guerrero updated the Board and audience on improvements on several streets of the Town including Hidalgo, Alvarado, Santa Ana, Balboa, Zapata, Bolivar, and Cortez Ave and lift station #1

11. FEBRUARY 2020 FINANCIAL REPORT - TOWN ADMINISTRATOR

Town Administrator Fred Blanco went over the February 2020 Financial Report.

Alderman Vera questioned Mr. Blanco on the increase in payroll for Police Budget. Mr. Blanco explained it was due to the payout given to the former Chief of Police for vacation and sick days.

Mr. Tumlinson also asked about the increase in insurance in the Police budget. The Board agreed to move to the next item while Mr. Blanco was able to gather the information asked for.

12. MARCH 2020 POLICE REPORT - POLICE CHIEF

Rancho Viejo Police Interim Chief, Roel Cantu went over the items of the March 2020 Police Report.

After the Police Report, Mr. Blanco answered Mr. Tumlinson's question regarding an increase in insurance and explained that it due to the former Chief and a former officer exiting while a new officer was hired and also advised that a credit was given in the invoice and will show on the next report.

13. PUBLIC COMMENT

Laura Kaechele shared her concern on the impact of closing Rancho Viejo's golf course and asked the Board to urge the County to re-open as other counties have. Mayor Rathbun informed Ms. Kaechele that it was not an order from the County but an order from Texas Governor Abbott. Alderwoman Guerrero stated that closures should be clarified if they are a mandate or recommendation. Mayor Rathbun reminded the Board and audience that while she is in support to have the golf course open, it is up to the Rancho Viejo Club to fight for re-opening as it is a privatized business. Alderman Tumlinson also noted that there was an opinion albeit not official by Attorney General Ken Paxton regarding golf courses. Alderman Grove further noted that Governor Abbott considered golf to be non-essential and that the County Judge should issue a clear mandate. Legal Counsel Daniel Rentfro advised that he is in agreement with Alderman Grove in that there should be a clear definition on essential activities. Interim Police Chief stated that complaints were received by Cameron County Sheriff's office and that the order to shut down the golf course was a direct order from them.

Rene Cardenas asked about the status on having ambulance and fire services in Rancho Viejo. Mayor Rathbun informed Mr. Cardenas that Dr. Wells was in the process of gathering a team for training when the pandemic essentially halted the process. Mr. Cardenas also inquired on the status of the hiring of the Police Chief for Rancho Viejo.

Alderwoman Salinas announced that the Town of Rancho Viejo was awarded the Operation Stone Garden Grant in the amount of \$71,000 and noted that the amount would be used for another license reader, software, and overtime.

Motion to close public comment was made by Alderman Grove, seconded by Alderman Vera and carried unanimously.

RESOLUTION

A JOINT RESOLUTION OF THE BOARD OF ALDERMEN OF THE TOWN OF RANCHO VIEJO AND THE BOARD OF DIRECTORS OF THE VALLEY MUNICIPAL UTILITY DISTSRICT NO. 2 IN SUPPORT OF DREDGING AND MAINTENANCE OF THE RESACA DEL RANCHO VIEJO IN THE VICINITY OF THE TOWN OF RANCHO VIEJO

Whereas, the Resaca del Rancho Viejo is an ancient distributary of the Rio Grande Delta which was severed from the Rio Grande River when the International and Boundary Water Commission flood control levee was installed, and

Whereas, the Resaca del Rancho Viejo's watershed contains an area of approximately 46 square miles, mainly to the west of Rancho Viejo, during catastrophic rain events, and

Whereas, the portion of the Resaca del Rancho Viejo within the Town of Rancho Viejo serves as a reservoir for the Valley Municipal Utility District No. 2 for the purpose of storing raw water for both potable water treatment and agricultural irrigation, and

Whereas, development, lack of natural water flow, and natural shoaling has caused the resaca to become significantly silted in over recent decades, resulting in both a loss of capacity for reservoir storage and for its ability to convey flood waters from upstream, and

Whereas, the Resaca del Rancho Viejo serves as a water amenity which increases the value of property in the Town of Rancho Viejo, and

Whereas, the resaca is utilized by many of the residents of the Town of Rancho Viejo for boating, and the high silt level impairs the ability to navigate a vessel, and

Whereas, the Rio Grande Valley is one of the most biologically diverse ecological regions in North America and a critical migratory stopover for birds moving between the Americas, and

Whereas, a valley wide drainage study titled the "Lower Rio Grande Valley Economic Adjustment Plan for Building Disaster Resilient Communities" which was prepared for the Lower Rio Grande Development Council in 2012, and funded by the U.S. Department of Commerce – Economic Development Administration listed the Dredging of the Resaca del Rancho Viejo in the Town of Rancho Viejo as one of its necessary projects,

Now, therefore, it be resolved by the Board of Aldermen of the Town of Rancho Viejo, and the Board of Directors of the Valley Municipal Utility District No. 2, as beneficiaries of the existence of the Resaca del Rancho Viejo, hereby support the investigation by both parties to find economical ways of restoring and preserving the Resaca's natural state.

DECLARATION OF LOCAL DISASTER FOR PUBLIC HEALTH EMERGENCY

- WHEREAS, BEGINNING IN DECEMBER 2019, A NOVEL CORONAVIRUS, NOW DESIGNATED COVID-19, WAS DETECTED IN WUHAN CITY, HUBEI PROVENCE, CHINA, AND HAS SINCE SPREAD THROUGHOUT THE WORLD; AND
- WHEREAS, SYMPTOMS OF COVID-19 INCLUDE FEVER, COUGHING, AND SHORTNESS OF BREATH, IN SOME CASES THE VIRUS HAS CAUSED DEATH; AND
- WHEREAS, EXTRAORDINARY MEASURES MUST BE TAKEN TO CONTAIN COVID-19 AND PREVENT ITS SPREAD THROUGHOUT THE TOWN OF RANCHO VIEJO, INCLUDING THE QUARANTINE OF INDIVIDUALS, GROUPS OF INDIVIDUALS, AND PROPERTY AND, ADDITIONALLY, INCLUDING COMPELLING INDIVIDUALS, GROUPS OF INDIVIDUALS, OR PROPERTY TO UNDERGO ADDITIONAL HEALTH MEASURES THAT PREVENT OR CONTROL THE SPREAD OF DISEASE; AND

NOW, THEREFORE, BE IT PROCLAIMED BY MAYOR OF THE TOWN OF RANCHO VIEJO:

- 1. THAT A LOCAL STATE OF DISASTER FOR PUBLIC HEALTH EMERGENCY IS HEREBY DECLARED FOR THE TOWN OF RANCHO VIEJO, TEXAS PURSUANT TO SECTION §418.108(A) OF THE TEXAS GOVERNMENT CODE.
- 2. PURSUANT TO §418.108(B) OF THE GOVERNMENT CODE, THE STATE OF DISASTER FOR PUBLIC HEALTH EMERGENCY SHALL CONTINUE FOR A PERIOD OF NOT MORE THAN THIRTY DAYS STARTING MAY 20, 2020 TO JUNE 19, 2020 UNLESS CONTINUED OR RENEWED BY THE BOARD OF ALDERMEN OF THE TOWN OF RANCHO VIEJO.
- 3. PURSUANT TO §418.108(C) OF THE GOVERNMENT CODE, THIS DECLARATION OF A LOCAL STATE OF DISASTER FOR PUBLIC HEALTH EMERGENCY SHALL BE GIVEN PROMPT AND GENERAL PUBLICITY AND SHALL BE FILED PROMPTLY WITH THE TOWN ADMINISTRATOR.

- 4. PURSUANT TO §418.108(D) OF THE GOVERNMENT CODE, THIS DECLARATION OF A LOCAL STATE OF DISASTER ACTIVATES THE TOWN'S EMERGENCY MANAGEMENT PLAN.
- 5. THAT THIS PROCLAMATION SHALL TAKE EFFECT STARTING MAY 20, 2020 UNTIL JUNE 19, 2020.

INVESTMENT POLICY

It will be the policy of the Town of Rancho Viejo to invest only in the items listed below. Safety of principal is the main concern in the investment of funds. Liquidity to meet reasonably anticipated operating requirements of the Town will be maintained.

- 1. Bank checking, savings and certificates of deposit secured by the pledge of U.S Government and/or municipal securities of the kind and value as prescribed in Chapter 105 of the local Government Code, Revised Civil Statues of Texas. Such pledge of security shall be made and maintained in accordance with and subject to the provisions of said Chapter 105.
- 2. United States Treasury bills, notes and bonds backed by the full faith and credit of the United States Government. Such securities will be purchased on a delivery versus payment basis and will be held in safekeeping by a bank with whom the Town has a depository contract.

The maturity of all investments will be less than one year.

Depository contracts for bank deposits will be approved by the Board of Aldermen.

Individual investments other than bank deposits will be authorized jointly by the Town Mayor and Town Administrator in written form.

PROCEDURES TO COMPLY WITH THE PUBLIC FUNDS INVESTMENT ACT

- 1. A copy of the investment policy adopted December 12, 1995 will be provided to the institutions authorized to provide investment services. The institutions must provide certification of having read the investment policy. The only institution at this time is Texas Regional Bank.
- 2. The investment officer is the Town Administrator/Secretary and he/she must attend at least one training session relating to his responsibilities under the Public Funds Investment Act.
- 3. A current audited financial statement of Texas Regional Bank will be kept on file and will be reviewed by the Mayor.
- 4. The annual internal control review will be conducted by Cascos & Associates, PC.
- 5. The monthly financial statements will include a breakdown of the investments of the Town.

WHEREAS, it is necessary that accounts be maintained at Texas Regional Bank for the payment of expenses of the Town and the deposit of monies received; and

WHEREAS, it is necessary that certain persons be authorized to sign checks for the withdrawal of funds from said accounts;

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF ALDERMEN OF THE TOWN OF RANCHO VIEJO, TEXAS, THAT:

Section 1. Required on all transactions shall be two signatures, one of these to be a primary signer which is the Town Administrator or Mayor. Secondary signers are any one of the other aldermen of the Town of Rancho Viejo.

Section 2. Required for entry to any safety deposit boxes shall be two signatures, one of these to be a primary signer which is the Town Administrator or Mayor. Secondary signers are any one of the other aldermen of the Town of Rancho Viejo.

Section 3. This resolution shall become effective on this the 12th day of May, 2020.
